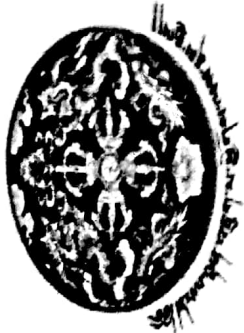


Transfer Request


The HRC reviewed the transfer proposal of Ms. Bunisha Pradhan, Architect and decided to endorse based on the genuineness of her problem based on following conditions;
