It would be very difficult for a lone Female HA to accomplish the unmet need of sexual and reproductive health rights of the public. As most of the service seekers of CHU are female which requires female health worker to protect their rights and privacy.

Moreover, services like Papsmear, VCT, ANC, PNC, family planning and gender related (female) demands female health workers.

Thus, in view of mentioned rationale, we would like to request your good office to kindly consider the transfer of Mrs. Chimi Wangmo.




